## Compensation for a Temporary Injury

Many victims of car accidents suffer from a variety of injuries, ranging from minor stiffness and pain to life-altering disabilities. The degree of the injury you sustained will have a significant impact on the settlement amount that you receive. Some of the highest settlements for hartford auto accident lawsuit accidents will be awarded for permanent disabilities, like spinal cord injury or brain injuries. These injuries could affect your ability to earn a living, work, or simply enjoy family activities for the rest of your life. They require ongoing medical attention and rehabilitation.

Other common types of permanent injuries include herniated or bulging discs within the spine. These injuries are caused by the abrupt force of a car crash, and could cause discs to tear or move. These injuries can cause extreme pain and could even require surgery.

In contrast to property damage which you're reimbursed for the costs you have already incurred in order to improve your financial situation. In addition, compensation for injuries-related expenses will help you get back to the situation you were in prior to the accident. This includes the loss of earnings as well as benefits, overtime as well as other economic losses that can be quantifiable.

## Compensation for Permanent Injuries

Some victims of car accidents sustain permanent injuries that dramatically alter their lives. In such instances, an attorney for personal injury can assist you to claim compensation for your losses. This includes the cost of medical expenses as well as lost wages and property damage, in addition to other expenses that are quantifiable. Your lawyer will determine your non-economic damages based on the pain and suffering you have experienced. In this case, your injuries are the main aspect.

If you suffer serious injuries, you may be able to sue directly the motorist responsible for your losses. However, you must do this within a specific period of time, also known as the statute of limitations. In addition the at-fault driver's policy may not contain sufficient coverage to cover your claim.

Even minor accidents can result in serious injuries. A whiplash injury, for instance can result in substantial medical bills due to treatment, visits to the doctor and surgery. The same is true of major accidents involving life-altering injuries.

But, it is important to keep in mind that settlements can vary according to the specific circumstances of your case.

## Compensation for Economic Losses

The most common method to pay for the medical bills and other economic losses you experience after a car accident is by receiving an settlement. The amount of money you receive is contingent on a variety of factors which include the extent of your injuries and the length of time it will be to treat.

Other losses include the amount of money you lost if your injuries have prevented you from working or from engaging in hobbies and other activities that were important for you prior to your accident. The insurance company might require proof of these expenses, as well as an opinion letter from a doctor explaining how your injuries affected your life quality.

Non-economic damages such as pain and suffering are more difficult to quantify than expenses that can be quantifiable like medical

expenses and lost wages. To help to compensate for these losses the insurance company typically uses a multiplier that is based on medical expenses. The more the multiplier is higher, the more severe your injury.

New York does not limit the amount you can claim in damages for suffering and pain. However many states do. A trusted lawyer can assist you in understanding what your insurance company is offering you and help you get the compensation you deserve.

#### Compensation for Non-Economic Losses

While economic damages are relatively straightforward to calculate, non-economic losses can be much harder. These can include emotional suffering and suffering, the loss of enjoyment due to the inability to participate in your recreational or hobby activities, the loss of consortium if you are married, and even a disfigurement. A knowledgeable attorney can assist you in determining the extent of the non-economic damage and make sure you receive the right compensation.

You must have comprehensive and complete medical evidence to maximize your settlement. This includes police reports and medical reports from all doctors who treat you following the accident, photographs of your injuries and the damage to your vehicle, as well as any other evidence that may help you prove your claim. Keep copies of your documents, both digital and physical to accelerate the settlement process.

You may be entitled to punitive damages, in addition to economic and non-economic damages. These are intended to penalize the at-fault party for reckless or egregious conduct and discourage similar conduct in the future. They are not typically part of a settlement agreement for car accidents however, you could be awarded them if a jury finds that the at-fault driver acted maliciously or knowingly caused your injuries. They are not tax-deductible.
